(1) Hellman & Friedman Capital Partners IV, L.P., H&F Executive Fund IV, L.P., H&F International Partners IV-A, L.P., and H&F International Partners IV-B, L.P. (collectively, the "H&F Partnerships") owned the Common Stock sold. H&F Investors IV, LLC ("H&F Investors") is the general partner of each of the H&F Partnerships. The investment decisions of each of the H&F Partnerships are made by the investment committee of H&F Investors, which indirectly exercises voting and investment power with respect to the Common Stock. The members of the investment committee disclaim beneficial ownership of the shares, except to the extent of their pecuniary interest therein.

(2) All 3,098 shares are held by Mr. Healy for the benefit of Hellman & Friedman Capital Partners IV, L.P., H&F International Partners IV-A, L.P., H&F International Partners IV-B, L.P. and H&F Executive Fund IV, L.P. ("H&F Entities"). Mr. Healy disclaims beneficial ownership of the Common Stock, except to the extent of his pecuniary interest therein. H&F Investors IV, LLC is the general partner of each of the H&F Entities. Mr. Healy is a managing director of H&F Investors IV, LLC and a member of the investment committee.
