Award of time-vesting restricted stock pursuant to eLoyalty Corporation 1999 Stock Incentive Plan, subject to continuing employment.
- (1) The Award was approved by the Board of Directors of the issuer for purposes of 16b-3 and includes a tax withholding feature. 12,334 will vest on 2/29/2008. 30,000 shares have the following vesting schedule: 25% will vest on 2/28/2009 and 6.25% will vest each quarter until fully vested.
