(1) Each restricted stock unit represents the right to receive, following vesting, one share of First Solar, Inc. common stock.

The restricted stock units were granted as part of First Solar, Inc.'s annual equity grant to executive officers. These units are scheduled to vest annually from the grant date at a rate of 20% over each of the first three years, with the remaining 40% scheduled to vest in the final fourth year. For informational purposes only, the closing price of First Solar, Inc.'s common stock on April 28, 2008 was \$285.52.
