- (1) As disclosed in a Form 4 filing dated May 15, 2007, the reporting person previously exercised this option and sold the underlying securities. This Form 4 is being filed because the initial option grant inadvertently was not previously disclosed in a Form 4 filing. In addition, in connection with the completion of a review of the issuer's stock option practices by certain independent directors of the issuer, the reporting person agreed to adjust the measurement date for the exercise price of this option to the closing price of Hain common stock on October 8, 2002. Because the option had already been exercised, however, the reporting person agreed to an amendment to the exercise price of three outstanding options to reflect a higher price in an additional aggregate amount equivalent to the increase in the exercise price of this option. The amendment to the exercise price of the three outstanding options was disclosed in a Form 4 filing dated February 28, 2008.
