performance metric was met; therefore, these restricted units vest ratably on each of the first, second and third anniversaries of the date of grant. The remaining 93,006 performance restricted units, which will vest in equal amounts on February 25, 2012 and 2013, are shown in Table II. Restricted units are settled in shares of the issuer's common stock upon vesting.
