 - (1) Represents shares that were automatically withheld from shares issued upon vesting of Restricted Stock Units (RSUs) to cover tax obligations in a transaction exempt under Rule 16(b)-3. This difference was also incorrectly reported on Form 4 filed December 6, 2010.
