(1) Pursuant to the terms of a restricted stock agreement, the vesting schedule of this restricted stock is 25% on September 6, 2012; an additional 6.3% to vest on a day to be randomly determined in each of the next 11 calendar quarters (provided that in no event shall the days so chosen in two consecutive calendar quarters be less than 60 days apart from each other) following February 1, 2011; and the remainder of the total award to vest on September 6, 2015.
