The IPO closed on November 18, 2013.

Thereafter, an additional 10,908 shares subject to the option shall vest and become exercisable in equal monthly installments over the 12 months following the grant date on November 12, 2013, an additional 10,200 shares subject to the option shall vest and become exercisable in equal monthly installments over the next 12 months thereafter, and the remaining 2,183 shares subject to the option shall vest and become exercisable in equal monthly installments over the next 12 months thereafter, until such time as the option is fully vested, subject to the continuing employment of the Reporting Person on each vesting date.
