- (1) Represents shares of the Issuer's Class B Common Stock, the receipt of which the Reporting Person has elected to defer, resulting from the Reporting Person's reinvestment of dividend equivalents accrued during the previous quarter on deferred but vested Restricted Share Units ("RSUs").
- (2) Adjusted to reflect 580 shares of the Issuer's Class B Common Stock representing dividend equivalents paid on deferred but vested RSUs that were previously reported as Restricted Share Units on Table II and are now reported on Table I.
- (3) The Reporting Person has elected to defer payment of director retainer and meeting fees and related interest thereon pursuant to the Viacom Inc. Deferred Compensation Plan for Outside Directors, as amended and restated as of November 13, 2013. Deferred amounts (including cash dividends and interest credited during the previous quarter) are invested quarterly in a number of vested RSUs that such amounts would have purchased on the day the amounts are invested. The RSUs are paid out six (or more) months after the Director's retirement from the Board and are settled in shares of Class B Common Stock.
