- (1) Bain Capital Investors, LLC ("BCI") is the administrative member of Bain Capital Integral Investors 2006, LLC ("Integral 2006") and BCIP TCV, LLC ("BCIP TCV" and together with Integral 2006, the "Bain Entities").
The governance, investment strategy and decision-making process with respect to investments held by the Bain Entities is directed by BCI's Global Private Equity Board ("GPEB"). Joshua Bekenstein is a Managing Director of BCI and a member of GPEB. By virtue of the relationships described in these footnotes, Mr. Bekenstein may be deemed to share voting and dispositive power with respect to all of the shares of Common Stock held by the Bain Entities. Mr. Bekenstein disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
- (3) On January 22, 2015, the Bain Entities distributed 436,617 shares of Common Stock to one or more members or partners of the Bain Entities including 120,022 shares to Mr. Bekenstein in connection with certain charitable gifts made by each member or partners on January 22, 2015.
- (4) Mr. Bekenstein made a charitable gift of all 170,022 shares of Common Stock that he received in connection with the distribution.
