(1) On the date reported, Mr. Brotman received a distribution of 60,000 shares from the 1984 Brotman Family Trust that did not involve a market transaction. The price represents the closing market price of Costco common stock on NASDAQ on October 9, 2015. The price shown is a weighted average sale price for shares sold in multiple transactions; the sale prices ranged from \$153.82 to \$154.25 per share. The reporting person will provide to the issuer, any security holder of the issuer, or the SEC staff, upon request, information regarding the number of shares sold at each price within the range.
(3) Mr. Brotman disclaims beneficial ownership of shares owned by the trust. Mr. Brotman is not a trustee of this trust nor does he have investment control over the trust's assets. Mr. Brotman is one of a number of beneficiaries of the trust.
