  - (2) The shares were withheld by Visteon to satisfy income tax withholding obligations arising in connection with the vesting of certain performance rights. The value of each share was based on the fair market value of Visteon common stock as of January 8, 2016.
  - (3) The reporting person has transferred 28,826 shares of Visteon common stock to his ex-wife pursuant to a domestic relations order. The reporting person no longer reports as beneficially owned any securities owned by his ex-wife.
  - (4) Each performance right represents a contingent right to receive one share of Visteon common stock. The performance rights vest based on a total shareholder return goal over a three year performance period and are payable in stock or cash at the election of the Company.
