## Explanation of Responses:

- On February 23, 2015, the reporting person reported the grant of certain market restricted stock units (the "MRSUs"). The MRSUs have a service-based vesting component as well as a Total Shareholder Return Multiplier. On February 19, 2016, pursuant to the terms of the service-based vesting component of the MRSUs, the first tranche of such award vested. Based upon the Total Shareholder Return Multiplier, the reporting person received 126 additional shares of the Company's restricted stock, such shares representing the amount vested in excess of the target amount of MRSUs initially reported on Form 4 in February 2015. In addition, the reporting person received 23 shares of the Company's restricted stock through the accrual of dividend equivalents.
- (1) Includes 40 shares acquired through dividend reinvestment.
  - (2) These shares were withheld upon the vesting of restricted stock units to pay tax withholding obligations.
