The reporting person may also transfer the phantom stock units into alternative investment accounts in certain other instances if applicable ownership guidelines are satisfied.
- (3) The aggregate of 835.71 phantom stock units includes (a) 2.48 phantom stock units acquired through dividend reinvestment in the Harris Corporation 2005 Directors' Deferred Compensation Plan ("Plan") on 5/31/17 and (b) a reduction of a .13 phantom stock unit due to rounding of previous reports by the Plan's recordkeeper.
