- (1) In lieu of receiving cash fees, the reporting person received 153 stock units, which immediately vested, in the EnerSys Voluntary Deferred Compensation Plan for Non-Employee Directors (the "Plan").
This amount reflects a matching stock unit contribution by EnerSys for the reporting person's account in the Plan. The matching stock unit contribution vests 25% on each of April 16, 2018, July 16, 2018, October 16, 2018, and January 16, 2019. Such vesting is subject to acceleration or cancellation upon the occurrence of certain events.
