- (1) These restricted stock units are issued under Sprint Corporation's Amended and Restated 2015 Omnibus Incentive Plan. Each unit represents the right to receive one share of the underlying security at a date in the future.
- (2) These restricted stock units vest 33 1/3% on each of May 24, 2018, May 24, 2019 and May 24, 2020.
These restricted stock units are subject to performance-based vesting conditions based on the company's actual results compared to financial objectives established under the long-term incentive compensation plan, and vest 100% on May 24, 2020, subject to achievement of the performance-based vesting conditions.
- (3) These restricted stock units are subject to achievement of specified Company common stock prices during the period January 30, 2018 through May 31, 2021 (the "Performance Period") and, if achievement is met, vest 100% on May 31, 2022. Achievement varies from 0% to 120%, and in order to earn 100%, the volume-weighted average price over any consecutive 150-calendar days during the Performance Period must be at least \$8.00.
