- (1) The restricted stock units (the "RSU") convert into Issuer's Common Stock on a one-for-one basis.

The RSU shall vest in equal quarterly installments, at a rate of 1/4th of the RSU on March 1, 2019 and 1/4th of the RSU on each quarterly anniversary of March 1, 2019 thereafter for so long as the Reporting Person provides continuous service to the Issuer, such that the RSU shall be fully vested on December 1, 2019.
- (4) The shares subject to this option shall vest at a rate of twenty-five percent of the total number of shares on the one-year anniversary of March 1, 2019 and 1/16th of the total number of shares each quarterly anniversary of March 1, 2019 thereafter for so long as the Reporting Person provides continuous service to the Issuer, such that the total number of shares shall be fully vested on the four-year anniversary of March 1, 2019.
