- (3) The share equivalents are payable in cash upon retirement or after termination of employment.

The number of stock fund units represented by the balance of the participant's Company stock fund account may not exactly equal the number of stock fund units represented by a prior balance due to variance in the proportion of uninvested cash held in the reference fund used to determine unit values of the Company stock fund under the Plan.
- (4) Each performance share represents a contingent right to receive one share of Company common stock (or the cash equivalent).
