- The Reporting Person was granted 39,695 shares of Restricted Common Stock under the 2013 Stock-Based Compensation Plan. 13,834 time-vested restricted shares vest over a three year period as follows: 4,612 time-vested restricted shares on January 7, 2020 and 4,611 time-vested restricted shares on January 7, 2021 and 2022, respectively. 12,027 performance-based restricted shares are targeted to vest
- (1) on January 7, 2022 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 12,027. 13,834 performance-based restricted shares are targeted to vest on January 7, 2022 based on the Return on Invested Capital achieved by the Company compared to the ROIC target, with the final number of performance-based vested shares varying from 0 to 200% of 13,834.
