On February 12, 2015, the reporting person was granted an option to purchase 39,000 shares of the registrant's common stock, of which, (1) 27,300 shares vest in 12 equal quarterly installments from the date of the grant, and the remaining 11,700 shares vest in two equal increments based on the registrant's achievement of certain performance criteria within 30 months from the date of grant.
