**AMÉRICA MÓVIL ACQUIRES INTEREST IN ENITEL IN NICARAGUA AND MEGATEL DE HONDURAS IN HONDURAS**

**MEXICO CITY (MEXICO), June 22, 2004** . América Móvil, S.A. de C.V. (América Móvil) [BMV: AMX] [NYSE: AMX] [NASDAQ: AMOV] [LATIBEX: XAMXL], announced today that it has entered into an agreement with Megatel LLC and certain other investors to acquire a 50.03% controlling interest in Nicaraguan telecommunications company, *Empresa Nicaraguense de Telecomunicaciones, S.A.* , or ENITEL, which provides fixed, mobile as well as other telecommunications services in Nicaragua and a 100% controlling interest in *Megatel de Honduras, S.A. de C.V.*, which provides mobile as well as other telecommunications services in Honduras.

As of the end of March 2004, ENITEL had approximately 205 thousand wireline subscribers and 145 thousand wireless subscribers and Megatel de Honduras had approximately 61 thousand wireless subscribers. America Móvil currently owns a 49% interest in ENITEL.

The transactions are subject to various conditions, including regulatory approvals and are expected to close during July 2004.
