**Authorization for new drilling in the pre-salt region**

Rio de Janeiro, December 2 2009. – PETRÓLEO BRASILEIRO S/A - PETROBRAS, announces that it was granted authorization by the board of the National Petroleum Agency (ANP), yesterday, to drill a well in the northern area of the Santos Basin's pre-salt, outside of the boundaries of the blocks that have already been bid for in the region. The region is eligible to compose the areas that will be the object of the Onerous Transfer, as detailed in an Announcement the Company made on 11/19/2009, once Draft Bill No. 5941/09 has been approved.

The purpose of the operation is to gather information about the region, which has yet to be assessed. Drilling is expected to reach a depth of 6,425 meters. The data and studies that are collected will be delivered to the ANP and become public at the end of the process.

Petrobras intends to send the SS-53 drilling rig to the region, which is expected to kick-off the activities by mid December. The Company will be in charge of the operation and bear the costs of the drilling, since the intent is for the area to be developed in the future by Petrobras itself, after the signing of an Onerous Transfer agreement.
