### **Clarification about News: Strategic Alliances for Petrochemical**

Rio de Janeiro, January 04, 2010, Petróleo Brasileiro S.A – Petrobras wishes to clarify about the news published by the Brazilian press regarding a potential participation of the Company in the restructure of the petrochemical segment in Brazil.

On August 24, 2009, Petrobras confirmed that it started to analyze with Braskem strategic alliances opportunities.

Petrobras clarifies that the negotiation has improved significantly since then, but until now, the parties did not come to a conclusion.

The Company will announce to the market the final structure as soon as the parties get an agreement, as required by the current legislation.
