- Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were
- (4) accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
 - (5) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
