Bleichroeder, LLC (ASB), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is deemed to be the beneficial owner of 3,541,212 shares or 9.74% of the Class E Common Stock believed to be outstanding as a result of acting as investment adviser to various clients. The First Eagle Global Fund, a registered investment Company for which ASB acts as investment adviser, may be deemed to beneficially own 2,036,652 of these 3,541,212 shares, which equates to 5.6% of the Company's shares. Clients of ASB have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities.
