Arnhold and S. Bleichroeder, LLC (ASB), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, may be deemed currently to be the beneficial owner of 10,250,782 shares, or 16.1% of the shares believed to be outstanding, as a result of acting as investment adviser to various clients. Clients of ASB have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. 21 April Fund, Ltd. ("21 April"), a Cayman Islands company for which ASB acts as investment adviser, may be deemed to beneficially own 3,767,528 of these 10,250,782 shares, which equates to 5.92% of the Common Stock. 21 April's ownership of the common stock first exceeded 5% as of April 27, 2009.
