Mr. Rowan is amending his Form 3 to reflect that he owned no derivative securities of the issuer before becoming subject to Section 16, and is reporting on Form 4 his acquisition of equity securities awarded to him upon becoming subject to Section 16.
- (2) On 6/19/06, subject to the terms and conditions of the 1993 Executive Long Term Incentive Plan, as amended, the issuer granted an option to purchase 100,000 shares of the issuer's common stock with the following vesting schedule: 33,333 shares vest on 6/19/09, 33,333 shares vest on 6/19/10, and 33,334 shares vest on 6/19/11.
