In connection with its review of the consolidated financial statements for the fiscal year ended December 31, 2016, management of the Company determined that the previously issued financial statements contained in the Company s Quarterly Reports on Form 10-Q for the quarters ended June 30, 2016 and September 30, 2016 should be amended to correct errors in those financial statements.
