- (1) A portion of Mr. Feinberg's restricted stock units (3,381) that were granted on 1/25/2012 and 2/26/2013 vested on 5/1/2015. Upon vesting, 1,622 restricted stock units were withheld to satisfy the reporting person's tax liability.
