(1) On March 19, 2008, the Reporting Person was awarded the right to purchase from the Issuer 4,800 shares of restricted stock at a purchase price of \$1.00 per share, in lieu of a cash bonus under the Issuer's 2004 Incentive Stock Plan based on the achievement of certain performance objectives for the year ended December 31, 2007.
