Yoram Bronicki beneficially owns 20% of Bronicki Investments Ltd., and accordingly may be deemed to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the securities beneficially owned by the Bronicki Investments Ltd. However, Mr. Bronicki does not have voting or dispositive power over the shares of Ormat Technologies, Inc. held by Bronicki Investments, and disclaims beneficial ownership of all such shares, except to the extent of his pecuniary interest therein.
