- (1) Includes the following shares of previously granted restricted stock: 3,750 which vest on November 1, 2012, and 3,750 which vest on November 1, 2014. All vesting is subject to continuous employment with the issuer.
- (2) Fifty percent of the options vest after two years and the remaining 50% vests after three years.
- (3) Each unit of phantom stock is the economic equivalent of one share of Johnson Controls common stock.
- (4) The restricted stock units accrue under the Johnson Controls Restricted Stock Plan. The balance includes phantom stock units that settle 100% in cash, and relate to (a) restricted stock awards, (b) dividend equivalent units, and (c) transfers into the JCI stock fund.
- (5) Includes 1,333,564 phantom stock units acquired through the reinvestment of dividends on January 3, April 3, and July 3, 2012 at prices ranging from \$27.81 to \$32.60 per phantom stock unit.
