ITEM 8.01 OTHER EVENTS.

On November 7, 2014, the Registrant filed a Form 8-K to report that WHLR-Pierpont Center, LLC, a Delaware limited liability company (“WHLR-Pierpont Center”) and a wholly-owned subsidiary of Wheeler REIT, L.P., a Virginia limited partnership of which the Registrant is the sole general partner, entered into a Purchase and Sale Agreement (the “Purchase Agreement”) as buyer, with DDR Southeast Morgantown, L.L.C., a Delaware limited liability company, as seller (the “Seller”), for the purchase of a retail shopping center in Morgantown, West Virginia, commonly known as Pierpont Centre, for the sales price of Fourteen Million and 00/100 Dollars (\$14,000,000).

On January 14, 2015, WHLR-Pierpont Center closed the transaction and acquired Pierpont Centre for \$13,885,000.

No director, officer or affiliate of the Registrant is affiliated with the Seller.
