- (1) On March 15, 2017, the reporting person was granted 900,000 restricted stock units (?RSUs?). One sixth of such RSUs would vest if prior to March 15, 2021 the 15-trading day average closing price of the Company's common stock is greater than or equal to the target prices of \$0.65, \$0.80, \$0.95, \$1.10, \$1.25 and \$1.40, respectively. On April 6, 2017, 300,000 of such RSUs vested based upon their terms.
- (2) As permitted under the Company's 2016 Equity Incentive Plan, on April 6, 2017, the Company withheld 138,000 shares of common stock from the reporting person to pay certain FICA, Medicare and Income Withholding taxes in connection with the vesting of such RSUs.
- (3) Includes 73,529 shares of restricted common stock.
