(1) Includes 5,250 shares of restricted stock vesting in three equal annual installments beginning November 4, 2018, 1,159 restricted stock units vesting on November 6, 2018, 3,476 restricted stock units vesting in two substantially equal annual installments beginning on November 6, 2018 and 5,500 shares of restricted stock vesting in four equal annual installments beginning on November 6, 2018. The restricted stock units represent the contingent right to receive an equivalent number of shares of Malibu Boats, Inc.'s (the "Issuer") Class A Common Stock.

(2) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$52.00 to \$52.76, inclusive.
