- On July 6, 2007, the reporting person was granted an option to purchase 192,857 shares of common stock scheduled to vest in installments of 20% per year based on the Issuer's satisfaction of certain performance criteria for each of the 2007 through 2011 fiscal years. The performance criteria for each such fiscal year was met, resulting in in the vesting of the option as to 38,572 shares relating to the 2007 and 2008 fiscal years and as to 38,571 shares relating to each of the 2009-2011 fiscal years.
