If and when the Rights become exercisable, the holder of each Right initially would be entitled to purchase one one-hundredth of a share of Series Junior B Participating Preferred Stock at a purchase price of \$195 (both the number of fractional shares and the purchase price are subject to adjustment).

(3) Beneficial ownership of these shares is disclaimed.

(4) Based on the latest plan statement as of October 1, 2002.

(5) Options became exercisable in equal installments over a three year period commencing one year following the date of grant.

(6) Anheuser-Busch 401(k) Restoration Plan.
