Effective as of March 1, 2016, Mr. Bobby Bell, Executive Vice President, Wafer Inspection Division, KLA-Tencor Corporation (the "Company"), will be assuming a full-time role focused on integration planning in connection with the proposed merger between the Company and Lam Research Corporation, which was announced on October 21, 2015. Mr. Michael Kirk, Executive Vice President, Global Service and Support Division, will assume Mr. Bell's responsibilities as head of the Wafer Inspection Division. Mr. Kirk's responsibilities as head of the Global Service and Support Division will be reassigned to a Company Vice President, who will report directly to Rick Wallace, the President and Chief Executive Officer of the Company.
