- (1) This amended form 4 is being filed to correctly reflect the reporting person's direct ownership shares of SEI Investments Company ("SEI") common stock, which ownership was over-reported due to an inadvertent mathematical error by 30,090 shares. The reporting person's direct ownership of shares of SEI following the transactions reported on the original form 4 should have been reported as 17,862,186 shares, instead of 17,892,276.

- (2) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$23.25 to \$23.55, inclusive.
