(1) Shares reported were acquired pursuant to the Irwin Financial Corporation 2001 Stock Plan in lieu of cash payment for services as a director of the Company. The reporting person has direct voting power with respect to the shares but no investment power until ownership of the shares vest pursuant to the Plan and certain holding periods set forth in the Plan expire. The grant was approved by the Board of Directors on August 24, 2005.

(2) The Plan provides for phased-in vesting of rights to exercise granted stock options. In the year of the grant, optionee may exercise 25% of total options granted. In each of the three years immediately following the year of the grant, optionee may exercise an additional 25% of the options granted. Grant of option was made to reporting person in transaction exempt under Rule 16b-3.
