- On October 19, 2004, the Registrant was granted 1,000 shares of fully vested and unrestricted Modine common stock. The total includes 1,269.4272 units of Modine common stock indirectly held in the Registrant's Modine 401(k) Retirement Plan account, 41.5246 units of Modine common stock indirectly held in the Registrant's Modine Deferred Compensation Plan account and 3,788.1006 units of Modine common stock indirectly held in the Registrant's Modine Stock Fund account. The balance of the former ESOP account, a share-based account, was changed into a unitized fund account on 9/30/04. At that date, the market value of one share equaled 1.185058 units, which was used as the conversion basis. Before the conversion date the Registrant received a dividend into his former ESOP account of 22.2612 shares for September's dividend.
