- (1) On May 16, 2007 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 1,537 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest in two equal annual installments on the first and second anniversary of the date of grant. On May 18, 2009, 768 shares of the originally granted RSAs vested, of which 274 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
- (2) Between August 20, 2008 and May 20, 2009 the Reporting Person acquired the following shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan: (a) 54 shares pursuant to the Dividend Reinvestment feature of the Plan; and (b) 148 shares pursuant to payroll contributions. This information is based on a plan statement dated April 22, 2009.
