Represents a Restricted Stock Award from Adaptec Inc's 2006 Director Plan for 16,250 shares of common stock that would vest with respect to 33.33% of the shares on the first anniversary of the grant date and 8.33% of the shares quarterly thereafter, such that the award is fully vested on December 13, 2010.

A total of 32,500 of Non-Qualified Stock Options were granted on December 13, 2007 from Adaptec Inc's 2006 Director Plan. The option shall vest at a rate of 33.33% of the shares on the first anniversary of the grant date and 8.33% of the shares quarterly thereafter, such that the total option shares will be fully vested on December 13, 2010.
