(Attach extra Sheets if Needed) Petroleum Development Corporation (the "Company") files this report for a 15 day extension, from March 16 to March 31, 2006, for filing its Annual Report on Form 10-K for the period ended December 31, 2005. The Company will not file its Form 10-K by March 16, 2006 because it will be unable to complete the preparation of its consolidated financial statements and the work required to complete management's assessment of internal controls over financial reporting in accordance with Section 404 of Sarbanes-Oxley by the initial filing date without unreasonable effort or expense. The Company anticipates that it will be able to file its complete Annual Report on Form 10-K by March 31, 2006. This extension is due, in part, to the additional work required to complete the recently filed restatement of its 2004 consolidated financial statements on Form 10-K/A and the 2005 first quarter consolidated financial statements on Form 10-Q/A, and the subsequent filing of its second and third quarter of 2005 Form 10-Q's, the last of which was completed January 12, 2006.
