On July 8, 2005, the common stock of Toll Brothers, Inc. split two-for-one, resulting in the reporting person acquiring 6,244,303 shares owned direct, 500,000 shares indirect by the GRAT, 2,680,357 shares indirect by entity wholly owned by reporting person and 1,240 shares indirect in 401(k) Plan. All share balances in this report reflect the additional shares acquired in the stock split.
