LITTLETON, Colo.--Nov. 5, 2001-- Credit Suisse First Boston Joins Deutsche Bank to Provide \$5.5 Billion Commitment

EchoStar Communications Corporation (Nasdaq:DISH) announced today that Credit Suisse First Boston has joined Deutsche Bank to provide approximately \$5.5 billion to finance the company's announced merger with Hughes Electronics (NYSE: GM, GMH).

Credit Suisse First Boston's \$2.75 billion commitment replaces General Motors' temporary bridge financing and adds to the previously announced \$2.75 billion bridge commitment from Deutsche Bank to provide EchoStar with the total expected \$5.5 billion of financing necessary to consummate the merger.
