Award of restricted stock under the Company's 2003 Long-Term Compensation Plan (the "Plan"). The restricted shares vest in four equal annual installments on the first through fourth anniversary of the Grant Date. Vesting of each installment is contingent upon the Company's achievement of specific performance goals relative to a peer index.

- (3) Award of restricted stock under the Plan. The restricted shares vest on the fourth anniversary of the Grant Date.
