- (1) This number in line 3, column 5 was incorrectly reported on the previously filed Form 4. Footnote (2) also incorrectly stated that 1,145 already reported and restated stock units were distributed to the reporting person. This number is corrected to 7,000 in footnote (2) below. All other numbers and footnotes were correctly reported on the previously filed Form 4.
- (2) On October 24, 2008, 7,000 already reported and vested stock units, granted on February 18, 2003, were distributed to the reporting person, 727 stock units were distributed to the reporting person as shares of common stock (NTRS); 549 stock units were withheld in payment of Federal, State and Medicare taxes, and 5,724 stock units were deferred.
