Pursuant to the terms of the Wingstop Inc. 2015 Omnibus Incentive Compensation Plan, the Compensation Committee reduced the

(1) exercise price of options to purchase 26,316 shares by \$2.90, the amount of the special cash dividend paid on July 15, 2016, from an exercise price of \$19.00 to an exercise price of \$16.10. The other terms of the options remain unchanged.

(2) The options will vest in five equal installments annually beginning June 11, 2017.
