(1) The reporting person previously elected to defer 563 shares of restricted stock vesting on January 13, 2017 (the shares of restricted stock were originally granted on January 13, 2015), and accordingly received 563 shares of phantom stock on January 13, 2017 pursuant to the PDC Energy, Inc. Amended and Restated Non-Employee Director Deferred Compensation Plan (the "Plan").
